Cash Value 现金价值

- In June 2011, Apple, EMC, Ericsson, Microsoft, RIM, and Sony won the auction of Nortel's 6000 patent portfolio for a total of \$4.5 Billion
- 在2011年6月,苹果,EMC,爱立信,微软,RIM,和索尼以总额为45亿美元的拍卖价获得北电的6000多个专利的专利组合
- Qualcomm's IP royalty total of \$4 Billion in 2010
- 高通公司在2010年的IP的许可费收入总额为40亿美元



Cash Value 现金价值

- In 2005, medical device maker Medtronic paid 1.35 Billion in settlement with Dr. Gary Michelson
- 2005年,医疗设备制造商美敦力公司在与加里迈克尔逊博士 的诉讼支付13.5亿美元后和解
- In 2004, Sun Microsystems won more than \$1 Billion to settle with Microsoft
- 2004年,Sun公司在和微软和解时赢得超过10亿美元



Cash Value 现金价值

- In 2009, SMIC settled with TSMC in a series of litigation started in 2002
 - \$200 million payment
 - 8% of SMIC's issued share capital and another 2% option

 - 授予中芯国际已发行股本的8%,加上另外2%的股权
